TOWNSHIP COMMITTEE MEETING - NOVEMBER 7, 2019

Mayor Rizzo called the meeting to order at 6:15 p.m. and requested the Clerk to call the roll. The following members were present: Robert Lane, Jr., Nicholas Williams, and Mayor Carol Rizzo. Absent: Dr. Michael Brantley and Kevin B. McMillan

Also present at the dais were Richard J. Cuttrell, Municipal Clerk; Vito D. Gadaleta, Business Administrator; and Gene Anthony, Township Attorney.

Mayor Rizzo announced that the notice requirements of R.S. 10:4-18 have been satisfied by the publication of the required advertisement in the Asbury Park Press and The Coaster on January 3, 2019, posting the notice on the Board in the Municipal Complex, and filing a copy of said notice with the Municipal Clerk.

The following items were discussed in open session:

Mr. Anthony stated that he researched the Hotel/Motel Municipal Occupancy Tax and found that state statute amended the law in 2018 and earlier this year to allow for the tax to apply to transient accommodation. He will take the draft version of the ordinance prepared in 2009 (which was not adopted) and update it with new language for the Committee's consideration. Mayor Rizzo stated that the Township would realize about \$300,000 in annual revenue if this hospitality tax were imposed. The ordinance would include hotels, motels, and transient (air BNBs). Mr. Anthony added that the building owner or operator collects the tax and sends it to the State. The tax amount is 6%, the State sends the Township half of that amount and state retains the other half. Mr. Anthony will get sample ordinances from other municipalities that include air BNBs. Mayor Rizzo recommended Asbury Park and Belmar. The Committee asked that this be added to the next workshop meeting for further discussion.

Mr. Lane stated that a wreath laying ceremony will be held on Veterans Day at Veterans Memorial Park.

THEREFORE, BE IT RESOLVED, that the Township Committee of the Township of Neptune hereby authorizes the execution of an Interlocal Services Agreement with the Borough of Neptune City, a copy of which is on file in the Office of the Municipal Clerk, providing for the disposal of the Borough's brush at the Township Public Works Yard for two (2) years beginning January 1, 2020 at a rate of \$10.00 per cubic yard payable to the Township; and,

ESTABLISH GOALS FOR CONTRACTING WITH VETERAN OWNED BUSINESS ENTERPRISES, HIRING VETERANS IN THE MUNICIPAL WORKFORCE AND RECOGNIZING THE MILITARY SERVICE OF RESIDENTS IN THE CIVIC AFFAIRS OF THE TOWNSHIP OF NEPTUNE

Mr. Lane offered the following resolution, moved and seconded by Mr. Williams, that it be adopted:

WHEREAS, the New Jersey Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. (the "LCPL") permits counties and municipalities to establish by resolution qualified veteran-owned business enterprise (VOB) contracting programs; and

WHEREAS, the LPCL further authorizes municipalities to establish goals for the municipality in setting aside a certain percentage of the dollar value of total procurements to be awarded as contract to VOBs; and

WHEREAS, the LPCL provides that municipalities that have set goals for contracts awarded to VOBs shall make a good faith effort to attain any goal by tracking the award of contracts to VOBs; and

WHEREAS, the Township Committee of the Township of Neptune have determined that, subject to compliance with the LPCL and other state regulations concerning procurement and New Jersey Civil Service rules concerning hiring that it is in the best interest of the Township to encourage the participation of veterans in the business of local government, the workforce and in the civic affairs of the community.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Neptune, that the Township will make a good faith effort to achieve the following goals:

- 1. Proactively notify veteran-owned businesses registered with the State of New Jersey (https://www20.state.nj.us/TYTR_SAVI/vendorSearch.jsp) of each public bid opportunity
- 2. In the procurement of goods and services, in accordance with N.J.S.A. 40A:11-42(d), the Township shall make a good faith effort to award 6% of the total contract dollars to Veteran Owned Business Enterprises. In achieving this goal, the Township shall consider the portion of any public contract awarded that may be performed by a VOB subcontractor;
- 3. In the hiring of employees, the Township, subject to all applicable New Jersey Civil Service regulations shall make a good faith effort hiring achieve the goal of a minimum 5% veteran workforce;
- 4. A discount for veterans on local license and permit fees;
- 5. Preferred parking for veterans in municipally-owned lots;
- 6. Hold at least one "Patriot Day" public celebration honoring the service of veterans on Memorial Day,

BE IT FURTHER RESOLVED that in order to achieve the goals established by this resolution the Township shall make best efforts, in accordance with N.J.S.A. 40:11A-43, to advertise to the VOB community the Township goals, to track the award of public contracts to VOB's or VOB subcontractors and assist those enterprises in the participation of the procurement process; and,

BE IT FURTHER RESOLVED, that a certified copy of this resolution be forwarded to the Business Administrator, Chief Financial Officer, Purchasing Agent, and Human Resources Director.

PRIVILEGE OF THE FLOOR/PUBLIC COMMENTS

BILL LIST TOTAL

Jack Bredin, 94 $\frac{1}{2}$ Heck Avenue, congratulated the winners of the election and also the losers for being brave enough to get engaged. He stated that any air BNB tax ordinance would

have to go to the Planning Board for approval. Mr. Anthony replied that it does not. Mr. Bredin stated that an air BNB is a business so the Planning Board would have to review because it would be a change to the existing single family residential zoning in Ocean Grove. He added that the difference between Township Committee members and Planning Board members is Committee members can govern based on their opinion while Planning Board members have to leave their personal opinions aside, follow the letter of the law, and determine if an application is correct.

Joan Venezia, 107 Mt. Hermon Way, asked Mr. Lane if, as a member of the Planning Board, he received the documents for the North End application being heard on November 13th. Mr. Lane stated that he received the documents and will be reviewing it all this weekend. Ms. Venezia asked him to look at the height of the hotel and the number of parking spaces. She asked if a meeting has been scheduled with MURC about Police Department and Board of Education involvement in the gun violence issue as discussed at the last meeting. The Mayor stated that there have been conversations about the issues and we need to look at it from a social services perspective. An ongoing conversation is needed among the members of the community which the Township could facilitate. She also has been discussing keeping school gymnasiums open at night with the Superintendent of Schools. Ms. Venezia asked if the Committee is contemplating an ordinance to ban the use of plastic bags and an ordinance to impose an air BNB tax. The Mayor responded that there are no plans for an ordinance to ban plastic bags and the Committee is looking at implementing a tax. Mr. Anthony stated that the tax would also include hotels and motels. Mr. Anthony added that residents should not submit questions or comments regarding the North End project to Mr. Lane in his capacity as a Planning Board member. The Planning Board is a judiciary board and can only review the submitted application and testimony provided at the hearing.

Mr. Lane offered a motion, seconded by Mr. Williams to adjourn. All were in favor.
