# **ASSIGNMENT OF LEASE**

KNOW ALL MEN BY THESE PRESENTS, THAT, I, JEFFREY R. JAMES and HEATHER JAMES, H/W, AS JOINT TENANTS WITH RIGHTS OF SURVIVORSHIP of 23 WEBB AVENUE, OCEAN GROVE (NEPTUNE TOWNSHIP), NEW JERSEY 07756,

In consideration of the sum of Seven Hundred Thousand Dollars and Zero/00 cents, (\$700,000.00) lawful money of the United States, to them duly paid by 23 WEBB, LLC, who are about to reside at 23 WEBB AVENUE, in the Township of Neptune (Ocean Grove) in the County of Monmouth and State of New Jersey 07756, the receipt whereof is hereby acknowledged have sold, assigned, transferred and set over, and by these presents, do sell, assign, transfer and set over unto 23 WEBB, LLC, their heirs, executors, administrators and assigns, a certain Indenture of Lease, bearing date the 1st day of October in the year Eighteen Hundred and Seventy three, made by "the Ocean Grove Camp Meeting Association of the Methodist Episcopal Church" of all that certain plot, piece or parcel of ground known and designated as Lot 674 on the Map of lots of Camp Ground of the Said Camp Meeting Association, situate in Neptune Township, in the County of Monmouth and State of New Jersey, with all and singular the premises therein mentioned and described, and the buildings thereon, together with the appurtenances.
